EXECUTIVE SUMMARY

The Washington State House Education Committee controls all K-12 education legislation affecting Moses Lake School District. This committee has **19 members total**:

- **11 Democrats** (controlling majority)
- **8 Republicans** (minority with no blocking power)

Key Finding: Democrats hold 58% of committee seats and control all agenda-setting, hearing schedules, and bill advancement. Republicans can speak and offer amendments but cannot stop legislation from advancing.

Moses Lake Connection: Rep. Kristine Reeves (D-30) is a Moses Lake native and Moses Lake High

School graduate (Class of 1999), creating a direct local connection to our district.
